- \bigodot connect $\underline{\text{DE-1}}$ to existing piping within wall, revise concealed piping and rough—in as required for New Installation.
- 2 RECONNECT (E) 1/2° CW FEED TO EVAPORATIVE COOLER, VERIFY EXACT LOCATION
- $\begin{picture}(40,0) \put(0,0){\line(0,0){100}} \put(0,0){\line(0,0){100$
- 4 CONNECT 1/4" HWC TO (E) AT FLOOR, PROVIDE BALANCING VALVE AT CONNECTION.
- 5 CONNECT 34" HW TO (E) 34" ACTIVE PIPING.
- 6 1" CW, 34" HW, 34" HWC & 4" G, SEE PLAN AT LEFT FOR CONTINUATION.
- $\boxed{7}\,\mbox{\%}^{\circ}$ CW, connect to (e) wall hydrant.

- (10) COORDINATE W/UTILITY COMPANY FOR INSTALLATION OF NEW GAS SERVICE AND METER, SEE TOTAL CONNECTED GAS LOAD SCHEDULE SHEET PO.2.
- (1) 3/4° CW, PROVIDE ISOLATION VALVE, DROP AND CONNECT TO (E) PIPING AT FLOOR.
- 12) ¾ RPBP-2 MOUNT NO HIGHER THAN 4'-0" A.F.F., EXTEND ¾ CW TO BOILER SYSTEM MAKE-UP CONNECTION, RE: HVAC.
- $\ensuremath{\textcircled{13}}\ensuremath{\mbox{2}''}$ G down, provide 1" g take-off to $\ensuremath{\mbox{HV}-1}\xspace$, continue 2" g down, extend and connect to boiler, re: HVAC.
- $\langle 14 \rangle$ 1" G to unit heater (HV-1), RE: HVAC.
- $\stackrel{\hbox{\scriptsize (15)}}{}$ Us ow down within wall, but wall and connect to water closets, see architectural drawings for PIPE enclosures.
- (16) RECONNECT TO (E) HW, CW, W & V PIPING, REVISE (E) PIPING AS REQUIRED BY NEW FIXTURE CONNECTIONS. PROVIDE <u>WMY-1</u> BELOW LAV.
- (17) RECONNECT TO (E) W & V BELOW FLOOR, REVISE (E) PIPING AS REQUIRED BY NEW FIXTURE CONNECTIONS.
- (18) 1/2° CW DOWN IN WALL, PROVIDE WHA-1 (W/AP) AND CONNECT TO WATER CLOSET.
- (19) 4" Building drain, see civil for continuation, i.e. \odot building wall = 96'-0". Field coordinate exact elevations prior to starting construction.
- (20) 2" W BELOW FLOOR, CONNECT TO (E). FIELD VERIFY EXACT LOCATION AND ELEVATION PRIOR TO COMMENCING INSTALLATION, COORDINATE FLOOR CUT & PATCH W/G.C.
- (21) 1/2" HW DOWN IN WALL, CONNECT TO LAVATORY.
- (22) REVISE (E) CW, W & V WITHIN WALL AND CONNECT TO (N) LAVATORY, COORDINATE W/G.C. FOR WALL CUT REQUIRED FOR CARRIER INSTALLATION, PROVIDE $\underline{WMV-1}$ BELOW LAV.
- (24) 2/2" G CONNECT TO (E) SERVING (E) BOILER AND (E) H&V UNIT DURING PHASE I CONSTRUCTION.
- (26) 1/2" CW DOWN TO ICE MAKER CONNECTION, PROVIDE STOP VALVE.

- (2) PROVIDE SPRINKLERS AT HIGH VOLUME THIS AREA PER NFPA REQUIREMENTS, RE: ARCHITECTURAL.
- (3) DRYPIPE VALVE, COMPRESSOR AND ACCESSORIES, EXTEND DRYPIPE SPRINKLER SYSTEM THROUGHOUT ATTIC.
